

Health, Safety and Environmental Policy

The AHJV consists of world leaders in creation of rail transport system. In this way, AHJV aims to be recognized among the best for the protection of HSE aspects for employees and the public.

The AHJV will adopt the following HSE Policy Statement for the Core System Contract expressing its commitment to the achievement of highest priority given to HSE aspects during the entire execution of the project from design to commissioning phases.

The HSE policy of AHJV is based on the application of the requirements of the relevant standards OHSAS 18001:2007 and ISO 14001:2004 and the other relevant rules applied at international level, on the full compliance with USA Federal Regulations, State of Hawaii Regulations and other Local Regulations applicable on the area, developing a program oriented to the continuous enhancement of HSE Standards.

Health and Safety Policy

For Health and Safety, AHJV undertakes:

- to establish, document, implement, maintain and continually improve a management system in compliance to OHSAS 18001:2007;
- to comply with USA Federal Regulations, State of Hawaii Regulations and other Local Regulations applicable on the area regarding a safe place of employment and safe practices, and will do everything reasonable and necessary to protect the life, safety and health of employees, suppliers, customers, visitors and the affected general public as well;
- to prevent accidents, illnesses or damages to the health of employees, suppliers, customers and visitors as much as is possible;
- to continuously enhance the performances not only in terms of prevention of accidents and occupational diseases, but also as regards the general well-being of the workers;
- to adopt, for all of the risks linked to the working activity, assessment criteria which, in compliance with national and international laws in force, also take account of best practices;
- to effect safe work places and practices by eliminating the existing or potential hazards by design where feasible, otherwise mitigating the hazards to acceptable levels through process substitution, employee training, and operating rules & procedures such as engineering and administrative controls, use of personal protective equipment, etc.
- to increase training and information activities for all workers, with the aim of increasing their awareness of the risks connected to their activity;
- to continue to develop activities in support of the spreading of a safety culture vis-à-vis all the suppliers and parties involved.

Environmental Policy

For Environmental, AHJV undertakes:

- to establish, document, implement, maintain and continually improve a management system in compliance to ISO 14001:2004;
- work in compliance with all USA Federal Regulations, State of Hawaii Regulations and other Local Regulations applicable on the area, through the formalization of this Policy which support the knowledge of the relevant legislative framework;
- prevent any environmental pollution
- identify significant direct and indirect environmental issues for offices and sites activities in order to control and monitor impacts on the environments including historical and cultural resources;
- involve staff, suppliers and contractors in the environmental issues, raising Environmental and Sustainability competency and awareness at all levels in the AHJV, Contractors and Suppliers
- continually improve the environmental performance through the achievement of increasingly ambitious targets and objectives, consistently with the Project and Company Environmental and Sustainability Target and with the budgeted expenses;
- to define indicators for a straightforward monitoring of performances.

The policy is notified and circulated to all employees of AHJV, sub-contractor and to all the interested parties through the web and the company intranet network and all the personnel involved in the project will be required to comply with this statement.
