## **Ansaldo STS wins EUR 80 million in Sweden**

- **The contract includes a total replacement of the existing signalling system on the Stockholm Underground**

Ansaldo STS (STS.MI), a Finmeccanica company, through its subsidiary Ansaldo STS Sweden AB, has awarded from SL, Storstockholms Lokaltrafik (Greater Stockholm Public Transport), a contract for re-signalling of Stockholm Underground.

The contract value is about EUR 80 million.

The contract includes a total replacement of the existing signalling system on the Red Line (41 km, 36 stations), as well as all onboard systems (30 trains) for the line, but can be extended to cover also additional lines and trains. The new signalling system employs state-of-the-art CBTC (Communication Based Train Control) technologies, developed by Ansaldo STS. This will provide more efficient, reliable and comfortable train operation, with a minimum amount of equipment on the track.

There is also an option to migrate to full driverless operation in the future. A key prerequisite is that the project, due to be completed in 2014, shall be conducted without interrupting normal daily services on the line. A further undertaking is the maintenance of the system, which is included in the contract as an option for up to 25 years.

This order once again manifests Ansaldo STS as the leader in the field of modern signalling systems for all types of rail networks and it proves the Ansaldo STS long-lasting reliability: the existing signalling system was provided by Ansaldo STS Group almost 50 years ago.
