## Update of the financial calendar 2013

Ansaldo STS (STS.MI) announces that the 2013 financial calendar published on 15 January 2013, has been amended providing the new dates for the Board of Directors' meeting to approve the Interim Management Report for the first quarter of 2013 (Monday 6 May, instead of "on a date to be set between 29 April and 3 May") and the shareholders' general meeting (single call, on Monday 6 May, instead of Wednesday 8 May).

It acts as lead contractor and turnkey provider on major project worldwide. Ansaldo STS is headquartered in Genoa, Italy, and employs over 4,100 people in 28 different countries. In 2011, its revenues reached € 1,212 M, with a gross operating margin of € 116 M and net profit of € 73 M.

Pursuant to article 2.2.3, paragraph 3 of the Italian stock market regulations, the Annual Report pursuant to article 154-ter, paragraph 1, will be published within 90 days of the end of the financial year, instead of the Fourth-Quarter Interim Report for 2012.

The presentation of the accounts to financial analysts normally takes place on the same day or on the day after the accounts are approved by the competent body.

Any changes to this calendar will be announced in good time.
